The data is processed for ensuring a smooth connection setup and system security.

Connection data is automatically deleted after seven days, unless retention is required to investigate misuse.

Cookies and Analysis Tools

This website uses “cookies,” text files stored on your computer that enable an analysis of your website use. The information generated by cookies is used to evaluate visitor behavior and improve our website. The legal basis for processing is Art. 6(1)(f) GDPR (legitimate interests). Optimizing our web presence constitutes such an interest.

The collected data is used exclusively for internal statistical analysis and is not shared with third parties. Cookies are typically deleted after two years. You may disable cookie storage in your browser settings, but doing so may limit the full functionality of the website. Data collection is anonymized and not personally identifiable.
